## Specialty School for STEAM

Some information was sent out today about specialty programs. There were lots of links to videos to watch.

Information from Kelly Brown: Elementary schools draw the fewest number of transfer students to specialty programs. It is a two year process to get approved. January 2025, send in our proposal. Fall of 2025-advertise and allow applications. Program would start Fall of 2026. Ms. Brown has volunteered to attend an advisory meeting.

Ms. Corbin: Has information on using grants to create a STEM program. This would require additional training or all teachers to take and become certified. It also must be all-inclusive.

Who decides if we go ahead and start this process? It is initiated from the principal with the support of the advisory council. Also need the support of the staff.

Teachers want to ensure that this program will not take away instruction time from the classroom. Mrs. Harrison thinks teachers would support it if it could be a part of our encore rotation.

Mrs. Brown suggests creating a smaller committee, or task force, to dive deeper into this process. How do we make this task force? Advertise in Cougar Chat and work of mouth. Advertise at BINGO night this Friday. PAC members can get it started and other can join later as word gets out.

It will take 24 students to fund an additional teacher for the program.

Mrs. Harrison will find out when proposal is due and invite Kelly Brown to the December PAC meeting.
